If you are a CURE supporter, we thank you for standing with us in healing the sick and demonstrating God's unconditional love to some of the most vulnerable people in developing countries.


We are looking forward to continuing our partnership with faithful donors as we carry out CURE's life-changing work.

The CURE teaching hospitals bring specialised medical care to children with disabilities in low-and middle-income countries. Here we are training the next generation of doctors, nurses, anaesthetists and other medical staff.

We are delighted to report back to you on what you helped us to achieve in 2017:

FINANICAL YEAR 2017 IMPACT

- ▶ **259,423** children visited CURE's outpatient clinics.
- ▶ **16,655** life-changing procedures performed so children can live free from disabilities.
- ▶ 236 mobile clinics were carried out to bring hope and healing to isolated patients.
- ▶ **585** volunteers mobilised across our CURE hospitals.
- ▶ 17,835 children newly enrolled in clubfoot treatment.

Meet Aretta

Beautiful Aretta was born fighting. When she was little, she did not let her clubfeet stop her from walking, even though she was constantly in pain. Her feet were so overextended that she was forced to walk on the tops of her feet.

In her village Aretta was constantly mocked for her disability as people shouted at her: "Aretta the cripple!"

One day, Aretta's mother heard about the CURE hospital. She was told that Aretta could be healed but would need multiple operations on her feet. This was followed by a series of casts and a long period of painful physical therapy.

Now at the age of six, Aretta is learning to walk on straight feet for the first time. She is going to school and she cannot stop smiling!

A monthly donation is by far the best way to help us plan ahead.

Did you know that it costs as little as £300 to provide treatment for a child suffering with clubfoot, so they may walk on straight feet? Just £800 helps to pay for a life-changing operation, so that a child can go to school and lead an independent life.
